



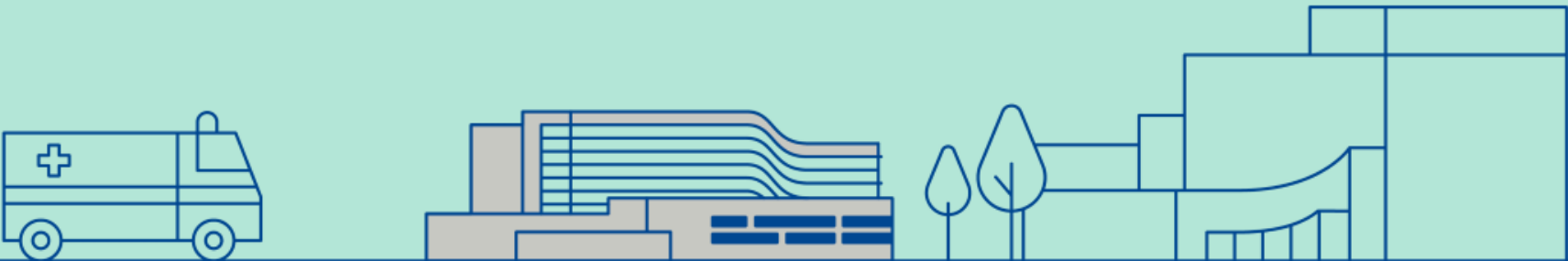

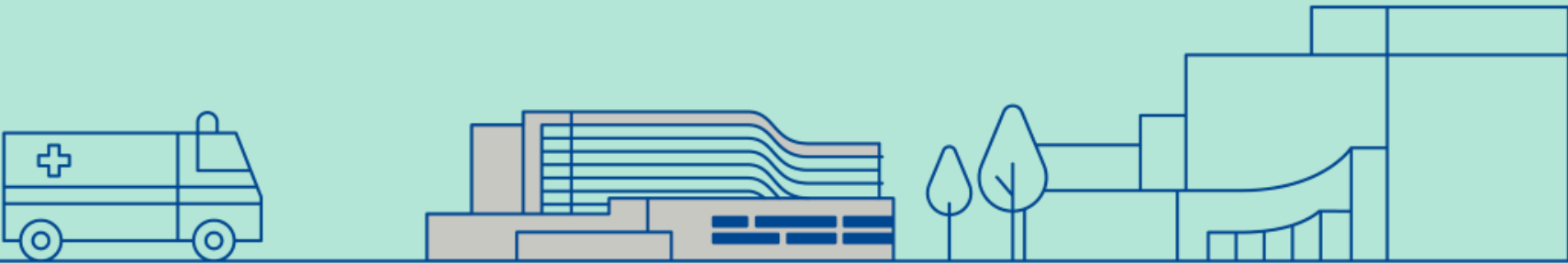

Nuvance Health and SHU will partner on curriculum, education and training initiatives to ensure students are optimally prepared to care for the evolving needs of our communities and patients.

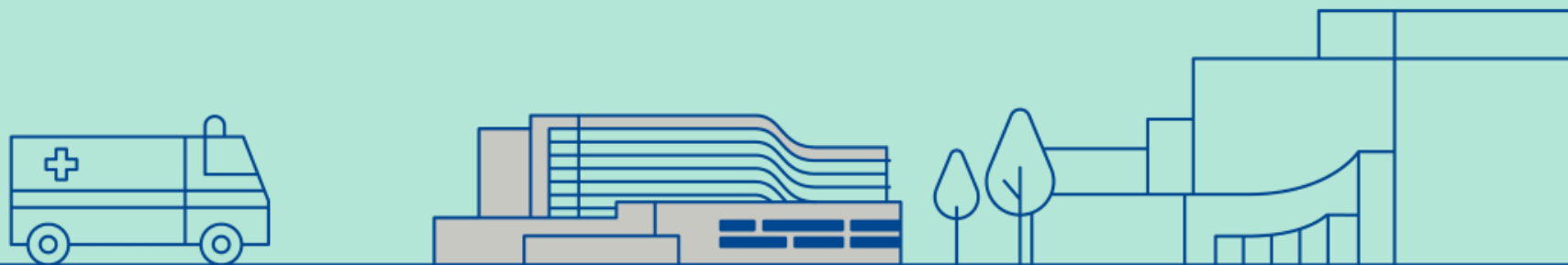

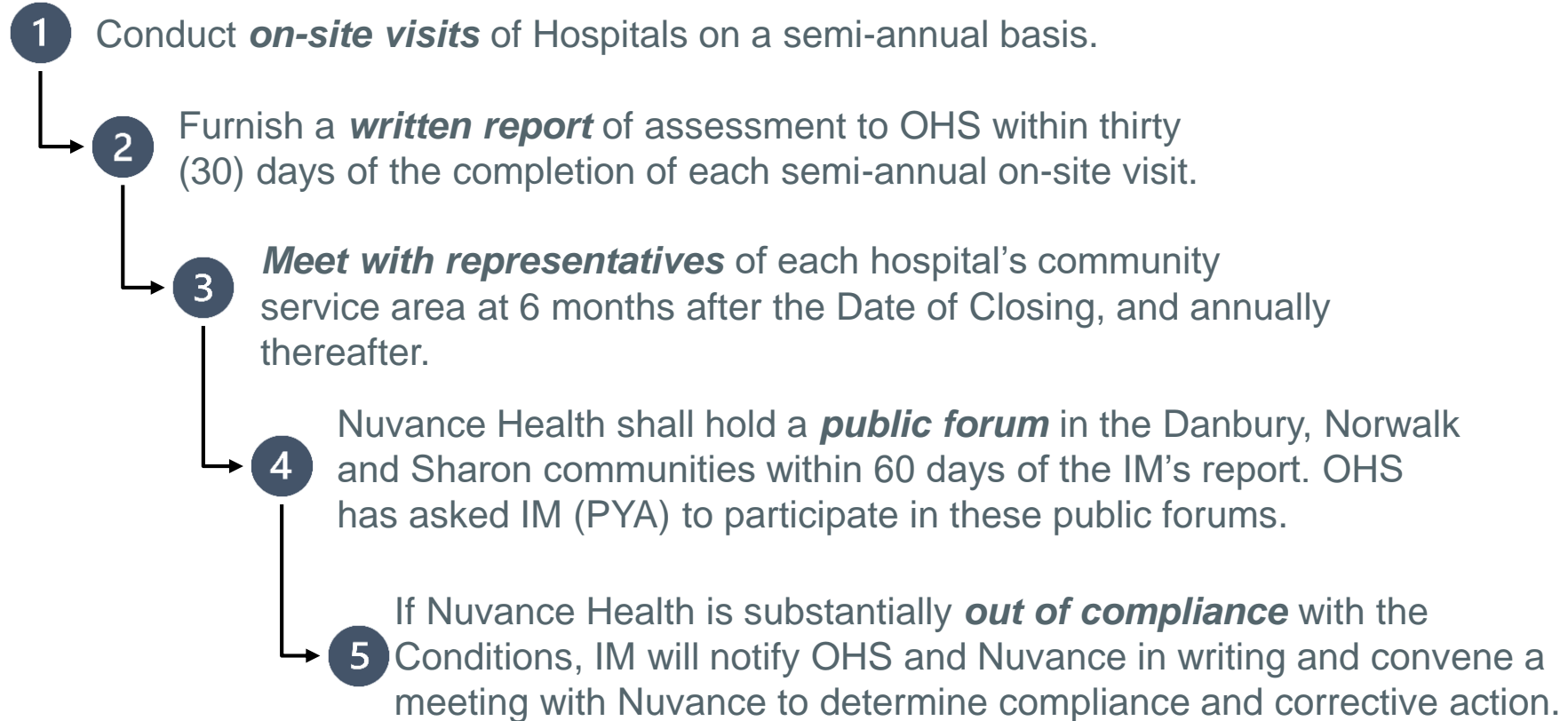

- ✓ Retained at sole expense of Nuvance Health
- ✓ Responsible for monitoring Nuvance Health’s compliance with the **Conditions** set forth in the **Agreed Settlement**.
- ✓ Retained by OHS for minimum of 5 years

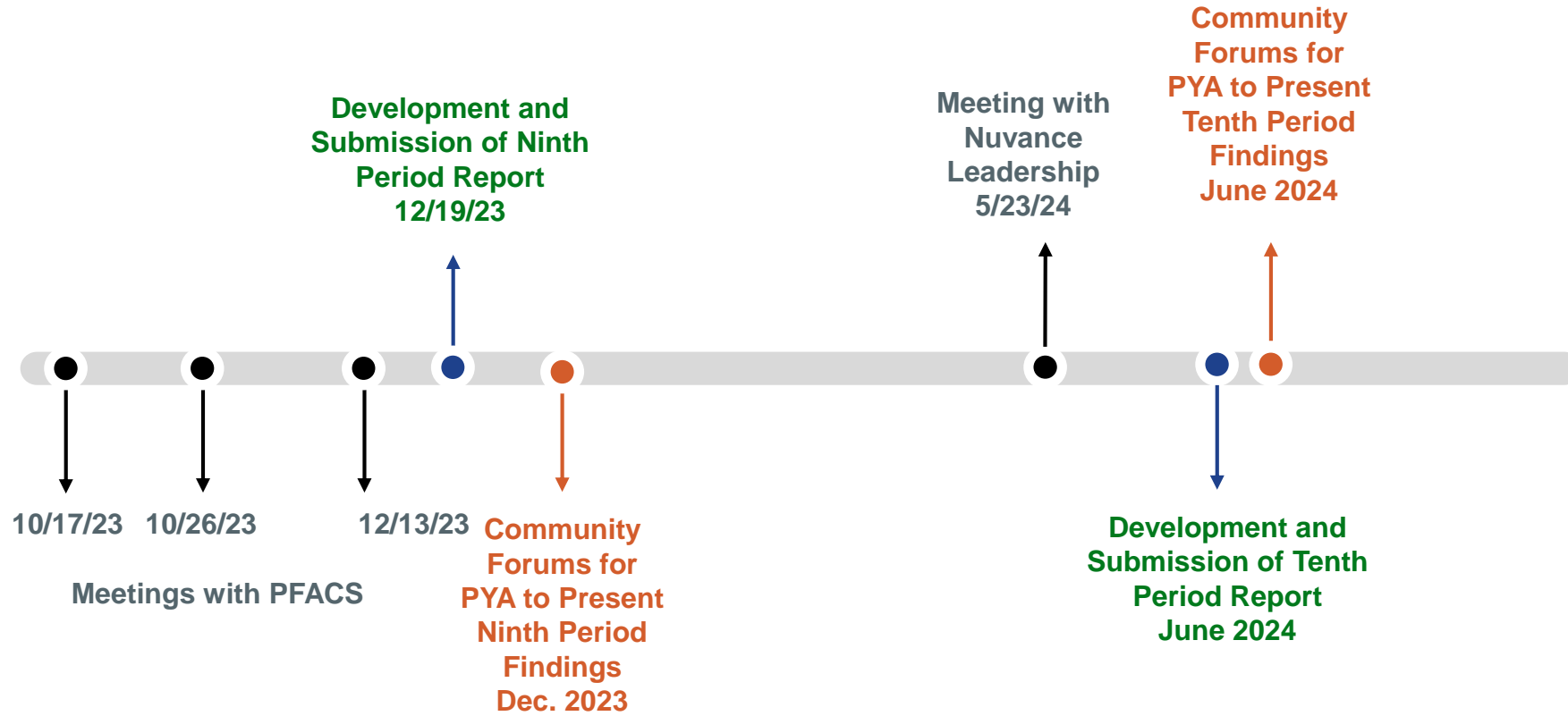
